This resolution is for approval of purchasing snow and ice control salt for FY2025. Typically each year we participate in the Iowa Department of Transportation (Iowa DOT) statewide letting to take advantage of bulk price discounts. The Iowa DOT held this letting on May 9, 2024, and Compass Minerals America was the low bidder at \$91.50/ton.

^{*}In FY2023, the Iowa DOT exercised their option to negotiate and renew contracts with FY2022 suppliers.

We requested a bid for 1,400 tons of salt. This contract will require that we purchase a minimum of 840 tons (\$76,860) and has the potential to purchase a maximum of 1,540 tons (\$140,910). We have \$240,000 in our FY2025 budget for snow and ice control materials. I recommend purchasing salt from Compass Minerals America, for FY2025, through the state contract at a price of \$91.50/ton.
